Thule Sleek Car Seat Adapter for Chicco

Product description

This recall involves the Thule Sleek Car Seat Adapter used to place a Chicco Car Seat in the Thule Sleek Stroller. The Chicco car seat and the Thule Sleek Stroller are NOT being recalled, only the adapter is being recalled.

The car seat adapter was sold under UPC number 091021188099, and product number 11000301. The product number is visible on a sticker located on the plastic bracket.

Hazard identified

In situations of overload, the car seat adapter can break, posing a fall hazard.

As of March 2, 2020, the company has received 1 report of breakage in Canada, and 1 report of minor injury. In the United States, the company has received 3 reports of breakage, and no reports of injuries

Approximately 87 units of the affected product were sold in Canada and approximately 1,430 were distributed in the United States

The affected products were sold from December 2018 to February 2020.
